You can prove this by proving evidence of:

- IELTS score of overall 6.0 (with no band less than 5.5) or equivalent score from another acceptable English language proficiency test or ELICOS (English Language Intensive Courses for Overseas Students) course provider. (Refer to English Proficiency Equivalence Table)
- Evident that you are enrolling in an ELICOS program before commencing course at SCA.
- Successful completion of the Senior Secondary Certificate of Education in Australia within the last two years
- Substantial component (75% or more units completed) of a course leading to an AQF qualification at the Certificate IV or higher level in the English language in Australia within the last two years.
- Successful completion of at least five years' study (including year 12 or equivalent) in one or more of the following countries: Australia, Canada, New Zealand, South Africa, the Republic of Ireland, UK and USA.

I understand that SCA reserves the right to withdraw an accepted offer if evidence becomes available that the application is not genuine.

I understand that I may be required to attend an interview to verify any information that I have supplied in the form.

I agree to tell SCA immediately if there is any change to the information I have given in this application.

I understand that if I am unsuccessful in the genuine temporary entrant (GSE) assessment a 2-year application exclusion from SCA may apply.

I understand that while, as part of my student visa, I am allowed to work a maximum of 40 hours per fortnight (with unlimited work- rights during semester breaks), these funds are to be used to supplement my living costs but must not be my only source of income to pay my tuition fees.

I have read and fully understand that if I request a transfer to another provider prior to completing six months of my principal course, SCA will access my request based on SCA's Overseas Student Transfer Policy and has the discretion to refuse transfer request.

I understand that it is my responsibility to maintain valid Overseas Student Health Cover (OSHC) for the duration of my student visa.

I confirm that funds are genuine and are to be used for no other purpose than to support me in my course(s) of study.

I authorise and give permission to SCA to:

- contact any of my employers or financial intuitions to verify the information I have supplied.
